The excess health risks associated with not breastfeeding are well known and acknowledged by *The Surgeon General's Call to Acton to Support Breastfeeding 2011* but the *psychosocial effects* are little mentioned except to note the enhanced feeling of bonding by breastfeeding with no mention of its powerful relationship to infant mortality (p.3). Child Obesity, not mentioned, is a lesser health risk than infant/child mortality.

The preventable death of a child is an unparalleled tragedy for a family. Similarly, a nation's ability to reduce child mortality rates is a measure of that society's overall well being, and failure to address preventable causes of child mortality is a national tragedy. Each year in the United States, more than 17 000 infants and children die from injury, which remains the leading cause of child mortality in the United States.1 Add to this the number of preventable noninjury deaths, including many deaths related to prematurity, and it becomes clear that a majority of American child deaths are preventable. —Introduction

Overpeck, et al (1998), NICHD investigators, reported "Homicide is the leading cause of infant deaths due to injury accounting for almost one third of such deaths in 1996.... More than 80 percent of documented homicides in very young children can be viewed as fatal child abuse, and there is strong evidence that both homicides and fatal cases of child abuse are underaccounted" (p.1211).

The problem of underestimating child abuse homicides in our society is reflected in a retrospective descriptive study of child abuse homicides in North Carolina from 1985-1994 by Herman-Giddens, et.al (1999). They found that the ICD-9 cause of death coding underascertained child abuse homicides by 61.6%. These studies have yet to be conducted for the other 49 states by the NICHD that would give a true national profile of the magnitude of child abuse homicides.

The National Center for Health Statistics (NCHS) informed this writer on 17 February 2011 that the "NCHS does not produce rankings for infant mortality by States", which denies to State officials and researches the information needed to evaluate the worst States to take corrective actions. It is inexcusable and unconscionable that this nation has such a disgraceful record of infant and child mortality, which contains a significant component of homicidal behaviors that includes violence against women. The intentional disregard by public health officials of these data calls for immediate corrective actions.

Madame Obama, you are urged to take the corrective actions that are necessary, which public health officials refuse to take.

You are to be commended for your support of breastfeeding in your efforts to help control obesity in children. There are, however, greater issues in the breastfeeding of children not addressed by Anne E. Kornblut in her article "Views on breast-feeding become political", *The Washington Post*, 2.20.11; and in *The Surgeon General's Call to Acton to Support Breastfeeding 2011*, U.S. Public Health Service, DHHS recently released by Surgeon General Regina M. Benjamin, M.D., M.B.A., USPHS.

Both of these reports neglect to mention the long-term psychosocial effects of insufficient breastfeeding on infant survival, which are staggering. In my letters to DHHS Secretary Kathleen Sebelius and DHHS Surgeon General Benjamin, I stated from reports on distribution of breastfeeding duration and infant mortality for 2004 by the *Center for Disease Control*, the following:

90% (9/10) States With Less Than 15% of Children Breastfeeding At 12 Months Have Highest Infant Mortality Rates

83% (10/12) States With Greater Than 25% of Children Breastfeeding At 12 Months Have Lowest Infant Mortality Rates

These letters are enclosed requesting remedial actions on the neglect of the DHHS to cite the overwhelming evidence of breastfeeding for the survival of infants and their emotional-social well being with supporting documentation and correspondence with NIH officials over the past five years.

Infant mortality could be virtually eliminated if all infants were breastfed, wherever possible, throughout the first year of life.

In 2005, the United States ranked 30^{th} in infant mortality among 31 advanced nations of the world (CDC); and 46^{th} among the 224 nations of the world (CIA World Factbook, 2010, est.).

No State records the number and percentage of infants who die during the first year of life **who** are being actively breastfed at the time of their death. It is requested that you request from Secretary Sebelius to act to provide from each State the number and percentage of children who die during their first year who were being actively breastfed at the time of their death; and that the Weaning Age of each child be made part of the immunological record and published along with the infant and child mortality rates for each Sate by the *National Center For Health Statistics*.

These data would provide an invaluable resource for determining the actual benefits of duration of breastfeeding with accuracy not currently available to researchers.

Your defense of breastfeeding mothers is sorely needed.

The gender equality of women in the legislative bodies of this nation is a necessary condition to bring full equality of women with men. You are urged to make this a reality. http://www.violence.de/prescott/letters/Gender.pdf
